## *Breast Health Leadership Award*

### **Criteria**

#### **The Award**

The Breast Health Leadership Award is presented annually during September or October to acknowledge a Maine woman or man who has made an exceptional contribution by promoting breast health, improving awareness and understanding of breast cancer, or working toward elimination of the disease.

Two awards are available to recognize professional and volunteer efforts that have contributed to breast health/breast cancer on the community, state, and/or national level. Nominees may be advocates, educators, leaders, role models, promoters of breast health, or promoters of women's issues. The Maine Breast Health Cooperative (MBHC) may choose to recognize more than one person in each category in response to extraordinary nominations.

#### **Eligibility**

Nominees must be Maine residents. Individuals campaigning for elected office during an election year are not eligible. If a nominee is a member of one of the organizations that comprise MBHC, the selection committee member from that organization will abstain from commenting on the application.

#### **Nomination Process**

Please use one copy of the nomination form for each candidate. To give your candidate the best opportunity, it is important that the application be completed in detail. Include relevant achievements as well as dates and/or timeframes. Resumes are helpful, as are letters of support, program information, newspaper articles, and other recommendations. (NOTE: Please submit no more than two letters of recommendation and a maximum of three pages of documentation in total, not including your nominee's resume. In addition, please submit six copies of your complete nomination package for the review committee.)

#### **Selection Process**

A selection committee of the MBHC and community volunteers will review all nominations. All nominees are recognized at the event. If your nominee is not selected, you may re-nominate the candidate in the following year.

#### **Deadline**

The deadline for nominations is Friday, July 30, 2010. Nominations postmarked after that date will not be considered. Please send entries to: Cindy Nesbit, 164 Roberts Rd., Bowdoin, ME 04287

#### **Notification of Award Recipient**

The award winner will be notified by August 27, 2010, and will agree to attend the award ceremony to receive her/his award. If she/he is unable to attend, the award will be presented to a representative designated by the award winner. After the award winner replies and accepts the award, all other nominees and nominators will be notified.

#### **Award Presentation**

In addition to honoring the Breast Health Leadership Award winner(s) at the Blaine House Silver Tea in Augusta, each nominee is recognized for her/his efforts. All nominees and their nominators are urged to attend.
